What cookies are?

Cookies consist of small data files that are sent to the users' browsers.

What is the use of cookies?

Cookies are used to help users of this website to browse, develop and display advertising material efficiently.

The company uses cookies to achieve the following: Purposes of using cookies: are for ensuring:

- Website displays as per visitors' preferences;
- Analysis of traffic, behavior, preferences, interests and trends of users;
- Company's partners are advertised to users.

For how long does the company keep Cookies?

The following types of cookie are used by this website:

- Necessary – these are cookies necessary for the functioning of the website.
- Statistical – these are cookies that provide information regarding the search device used by the visitor, the time spent; the IP address, the time spent on the website, how the website was used and the behavior of the visitor,
- Marketing - these cookies collect information for the purpose of matching advertisements and visitors based on their interests, social network, third-party advertisements, monitoring clicks on a partner advertisement and assessing their effectiveness among the different websites.
